Please join us this summer at Area 2's Challenge(R)ing for the Music Educators track dealing with the inclusion of handchimes/handbells in music programs to achieve the National and/or State Standards in Music.

This special summer event will be held in Hackettstown, NJ on Friday, August 5. The four-session track is designed for the public and private music educator. Sessions will include exploring teaching rhythms, ostinatos, chordal accompaniments, handchime/handbell ringing techniques, selections for ringing, resources for ringing, Q & A, and creating a performing handchime choir. Please note that the music is geared for public schools and is secular in nature. This track is designed to be completed in one afternoon and Professional Continuing Education Credits are offered to certified teachers in New Jersey and New York. (Due to the change in the regulations of the Pennsylvania Department of Education, we are no longer an approved provider. Therefore, we cannot issue professional development credits for Pennsylvania teachers.)

The registration fee is \$80. Registrants may attend without a membership if this is his/her **first** Handbell Musicians of America event. Track participants are invited to a free handbell concert and dessert reception at 7:00pm. Please note that dinner is on your own. There are many restaurants conveniently located in the area.

The minimum number of registrants is five. In the event of cancellation, the registration fee will be refunded.
